Terms & Conditions

The Ash Memorial Fishing Comp & Treasure Hunt is run by The Ash Memorial Foundation INC and its committee members. Please note where the following names are used "Ash Memorial Fishing Comp & Treasure Hunt 2025", "AMFC 2025" & "Ash Memorial Foundation INC" all refer to the same entity.

I agree to participate at the "Ash Memorial Fishing Comp & Treasure Hunt 2025" which is a Catch & Release Competition, or events, in which I am entering, on the following basis:

- By participating I accept all risks necessary from my participation which would result in loss of life or permanent injury.
 - Accordingly, I release all people associated with the conduct of events from, and will indemnify them against, all liability (including liability for their negligence) libel, slander, loss, damage, negligence, injury, harm or death for all injury, loss or damage arising out of or connected with my participation in events.
 - For clarification, the people released include event organisers, promoters, sponsors, managers, Ash Memorial Foundation INC Committee, and all of their respective directors, officers, employees, agents, contractors and volunteers, including event medical and paramedical personnel. This release and indemnity continue forever and binds my heirs, executors, personal representatives and assigns. These terms do not operate to exclude any provision of the Australian Consumer Law that applies and cannot be excluded by agreement.
- I acknowledge that such events involve the real risk of injury or risk of death from various causes, including over-exertion, equipment failure, drowning, dehydration, accidents with other competitors, spectators and water users, and weather conditions, just to name a few.
- I understand that I should not participate in events unless I have prepared appropriately and my physical condition has been verified by a medical practitioner, who has not advised me otherwise.
- I understand that the information I have provided herein will be included in a database held by The Ash Memorial Foundation INC I also understand that information supplied by me to the organizers including my name, date of birth, home state, results, and interests may be released to the media in response to general requests.
- I understand that compulsory insurance cover affected for participants in events and training does not cover me for all injury, loss or damage sustained by me, e.g. heart failure, muscle fatigue and boat accidents.
- The sanctioning process undertaken by The Ash Memorial Fishing Comp & Treasure Hunt 2025 and safety precautions undertaken by event organisers (such as weather supervision, competition safety briefings) are a service to me and other competitors but are not a guarantee of safety.
